RV PARK RULES & REGULATIONS

For everyone's mutual enjoyment, the park rules and regulations are in place for the consideration of all our guests/staff and for the protection of the property and environment.

THE PARK SPEED LIMIT IS 5 MPH AND IS STRICTLY ENFORCED

QUIET HOURS: Quiet hours are from 10:00 PM to 8:00 AM

RATES: Rates are based on a one-night stay. A maximum of 6 persons per site. Rates are for 4 persons. Pursuant to California Code 799.22, non-payment of balances due will result in the removal of your vehicle/RV. If you have not contacted the office by the check-out time of 12:00 PM, your credit card will be charged for another day. Maximum stay is 21 consecutive days per visit.

SITE NUMBERS ARE NOT GUARANTEED: We reserve the right to move you to another space, if necessary, at no cost to the park.

CHILDREN: Children must be under adult supervision at all times. Parents are responsible for their children's conduct and safety.

VISITORS: Facilities in this park are for use by registered guests only. Visitors must register at the office before entering the park. All visitors must leave the park by 10:00 PM. Guests and residents are responsible for their guests' actions.

VEHICLES: Maximum one RV and one vehicle per site. All vehicles must be parked within your site. No parking or driving on grass, empty sites, or roadways. Inquire at the front desk about additional parking options. All vehicles must be street-legal and currently registered to be allowed in the park. No ATVs or motorbikes are permitted to be operated in the park. Overflow parking is available with a parking permit. Tarps are not permitted on any RV/Vehicle for any reason. Washing RV & vehicles is NOT PERMITTED for transient guests. Repairing or servicing of any vehicle is not allowed at campsites.

ELECTRIC VEHICLE CHARGING POLICY: EV Charging is not allowed. Mad River Rapids RV Park's older power grid cannot sustain the continuous voltage required to charge an EV, and our electric hookups are not designed for this purpose. Charging your EV here could cause serious damage to our power grid and your EV. You will be liable for any and all damages related to attempting to charge your EV at this location.

GENERATORS & SPACE HEATERS: Generators and space heaters are PROHIBITED.

CAMPSITE STANDARDS: Campsites MUST be kept clean and neat, free of fire hazards and clutter. A dirty/messy campsite can invite unwanted wildlife. NO TENTS or sleeping outside of RVs is allowed. Please respect your fellow campers' space and refrain from walking onto sites or across their lawns.

SANITATION: If you notice a mess, let us know. If you leave behind garbage/pet droppings you will be charged a \$25 clean-up fee. Dishwashing and hair dying are not allowed in the restroom. No dumping of any water from your RV on to the ground is allowed. A sewer hose seal (rubber donut or threaded connector) for your sewer is REQUIRED.

PETS: Pets MUST be kept on a handheld leash (6ft max) at all times while outside. Please clean up after your pet. Pets are NOT allowed in the main building, pool area, clubhouse, laundry rooms, showers, or bathrooms. Never leave your pet unattended at your campsite. Continuously barking dogs/aggressive dogs will not be tolerated. No dangerous, aggressive, or poisonous pets of any kind are permitted. Management reserves the right to reject any pet. All pets must be registered with the office, and vaccination records must be available upon request.

POOL: No glass containers or alcoholic beverages are allowed in the pool area. After-hours use is strictly prohibited. Children under age 14 must be accompanied by an adult. Please use swim diapers for children who are not toilet trained. No running, jumping, or diving in pools or spas. No food in the pool. No glass in the pool area. No pets are allowed in the pool area. Large pool toys (balls, foam balls, etc.) are not permitted in the water. Proper swimming attire is required. SWIM AT YOUR OWN RISK—NO LIFEGUARD ON DUTY.

SPA: Children under 10 years old are not allowed in the spa with or without supervision. No food or drink is allowed.

FIREARMS & FIREWORKS: Firearms and fireworks are EXPRESSLY PROHIBITED!

TREES: You must advise park hosts/staff of any observable defect. Climbing trees is prohibited. Nothing may be hung from trees (including tarps, hammocks, clotheslines, etc.).

Wi-Fi: We offer WiFi service, but we do not guarantee its availability or security at any time.

WATERING: The lawns will be watered nightly as needed, so please be sure to keep all articles inside during the nighttime hours so they do not get wet.

EMERGENCIES: Mad River Rapids RV Park does NOT provide security or maintain personnel or hosts at the RV Park or Facilities at all times. Management is not responsible for loss due to fire, theft or vandalism nor are they responsible for accidents or acts of nature.

EVICITION BY MAD RIVER RAPIDS RV PARK: Mad River Rapids RV Park reserves the right to evict any person for detrimental conduct and/or violating the rules. Eviction may result in RV removal and impoundment. If the RV is impounded, a \$500 impound fee plus a daily storage fee applies.

Failure to comply with Park rules and regulations may terminate your stay without refund!
